The school authorities are requested to contact the member of the inspection committee for an early inspection.

Further, it is also informed that on scrutiny of the application of extension and documents submitted by school, the following deficiencies have been observed, which need to be complied by school before the periodical inspection of school and documentary evidences to this effect must be produced before the inspection committee at the time of inspection & duly attested copy of compliance be submitted along with Inspection Committee report.

1. The school has submitted the list of School Managing Committee but there is not mentioned name of the Principal as Member Secretary and also not available any female member in Committee. Hence, the school is again required to re-constitute SMC as per New Affiliation Eye-Laws, by including 02 representative of Parent of students are studying in school, 02 teachers from same school and 02 teacher from any other school or college (of whom one shall be woman), School Principal as Member Secretary, at least 50% member in SMC should be woman and 2 CBSE representatives not below the rank of Principal of Sr. Secondary School affiliated with the Board whose nomination should be recommended from the Board and also submitted list of members of School Managing Committee on non- judicial stamp with effect that no member is related to each other in School Managing Committee duly certified by the First Class Magistrate.

- 6 TGT teachers are short to appoint more teachers and also to maintain section teacher ratio i.e. 1:1.5 teachers per section at each level. Hence, the school is required to submit a copy of revised staff statement with showing Name, Qualification, Designation, Date of Appointment, Date of Confirmation etc.
- The school is required to procure more books, i.e., 05 books per student. Hence, the school is required to submit a copy of invoice in this regard.
- The school has submitted the FDR in joint name of Name of School & Dy. Director of Education, which is not acceptable as per Board norms. Hence, the school is again required to submit the renew copy of FDR to be in joint name of Principal of the school & Managing Trustee/ Member of the Trust/ Society/ Company as per Affiliation Bye-Laws.

However regularization of general affiliation from 01.04.2019 for a period of 05 years will be subject to the outcome of the inspection report and specific compliance of above deficiencies by the school.


